Electric Golf Cart Options:

- Single Unlimited: \$1,000

- Cart Storage Fee: \$500 Annually (FGL Manager approval required)

- One bucket of range balls on the day of play.
- Two guest rounds (guests must be accompanied by Pass Holder on the day of play).
- One ½ hour golf lesson gift certificate to be used anytime in 2023.
- Discounted rates on Florence Golf Links tournaments.
- Discounted room rental rates.
- Reciprocal rates with many Oregon golf courses, including Bandon Crossings Golf Course, Centennial Golf Club, Coos Golf Club, Diamond Woods Golf Course, Ocean Dunes Golf Links, and Salishan Golf Links.

Current 12-Month Pass Holder Options:

If you are a current 12-month Pass Holder whose pass expires in 2023 but want to take advantage of the purchase early savings now, FGL will pro-rate the remaining 2023 months on your current pass as a credit toward the purchase of a 2023 FGL Annual Golf Pass.

2023 FGL Golf Pass – Rules and Regulations

The 2023 FGL Golf Pass is non-transferable and non-refundable. Pass Holders not following the Rules and Regulations may have golf privileges suspended.

- Electric Golf Carts:
 - **Players must pair up in carts: 1 cart max for twosomes, 2 cart max for threesomes and foursomes.**
 - No more than two people per golf cart.
 - Golf Carts are restricted to the parking lot, practice range, and golf course.
 - Operators must have a valid driver's license to drive a cart.
 - Golf Carts must stay on the cart paths where available at all times.
 - Golf Carts must stay 30 feet away from the greens in any direction.
 - Golf Carts are operated at risk of operator. The Pass Holder will be responsible for the cost of repairing any damage to carts or the golf course resulting from improper operation.
- Driving Range:
 - Golf Pass includes one bucket of balls on the day of play.
- Dress Code:
 - Golf Attire is preferred but not required. Tee shirts, jeans, Cargo pants, and shorts are accepted. No tank tops, swimwear, or sweatpants.
- Food & Beverage:
 - All alcoholic beverages must be purchased from Florence Golf Links. No outside alcohol is permitted. Purchasing food on-site is preferred, but not required.
- Pace of Play:
 - **The first group of the day cannot tee off their second nine until 1 hour and 45 minutes after their original tee time.**
 - Pace of play for 18 holes should be between 3.5 and 4 hours.
- Tee Times:
 - **Pass Holders must check-in at the Golf Shop before play. Always...**
 - Online tee times can be booked up to two weeks in advance. Tee times can be made through the Golf Shop up to 30 days in advance.
 - **From May 1st through September 30th, the first tee time available for Pass Holders is 8 a.m. Pass Holders can move to an earlier tee time if one is available the day before their scheduled tee time.**
- Tee Time Cancellations & No-Show Policy:
 - Pass Holders are responsible for managing the number of players in their times booked. Any changes must be communicated to the Golf Shop as soon as possible but no later than 24 hours before the scheduled tee time.
 - **Pass Holders who no-show for a tee time will first receive a warning. After the first warning, Florence Golf Links reserves the right to charge the Pass Holder a \$100 No-Show Fee. Multiple no-shows may result in the suspension of golf privileges.**
