Golf Pass is good through December 31st, 2024

Golf Pass Options:

Unlimited Single: \$2,300
Unlimited Couples: \$3,100 Two people from the same household.
Afternoon Single: \$1,500 Afternoon only. Discounted morning rates.
Snowbird Single: \$1,700 Pick four months, add \$600 for a partner.
Non-Res. Single: \$1,700 Residence must be 50+ miles from course.

Electric Golf Cart Options:

Unlimited Single: \$1,000
Unlimited Couples: \$1,500
Afternoon: \$500

Pay Per Play: \$15 per rider for 18-holes, \$10 per rider for 9-holes.
 Trail Fee: \$500 Annually (FGL Manager approval required)
 Cart Storage Fee: \$500 Annually (FGL Manager approval required)

Benefits:

- 10% off golf shop merchandise excluding discounted items.
- Range balls on the day of play.
- Four free guest rounds.
- Discounted guest rates.
- Discounted room rentals.
- Discounted rates on tournaments.
- One ½ hour golf lesson to be used anytime.
- Reciprocal rates with many Oregon golf courses, including Bandon Crossings Golf Course, Centennial Golf Club, Coos Golf Club, Diamond Woods Golf Course, Ocean Dunes Golf Links, Salishan Golf Links and more.

^{*}Current Pass Holders: Purchase the 2024 Golf Pass before November 16th and take 15% off. Purchase before December 31st and get 10% off.

^{*}Snowbird and Non-Resident Golf Pass Holders can purchase an unlimited cart at 50% of the posted rate.

FGL Golf Pass - Rules and Regulations

The Golf Pass is non-transferable and non-refundable. Pass Holders not following the Rules and Regulations may have golf privileges suspended. Florence Golf Links reserves the right to close the golf course due to weather conditions at any time.

- ☐ Golf Pass additional details.
 - Afternoon Golf Pass:
 - Pass holders can play in the morning and at 30% off the regular rate.
 - A partner from the same household can be added for \$600.
 - o Snowbird Golf Pass:
 - You pick the 4 months. Additional months may be added for \$300 for each month.
 - Non-Resident Golf Pass:
 - Your primary address and driver's license address must be 50+ miles from the golf course.
 - A partner from the same household can be added for \$600.

☐ Electric Golf Carts:

- Players must pair up in carts: 1 cart max for twosomes, 2 cart max for threesomes and foursomes. No exceptions, anytime of year.
- o No more than two people per golf cart.
- o Golf Carts are restricted to the parking lot, practice range, and golf course.
- Operators must be 18+ years and have a valid driver's license.
- o Golf Carts must always stay on the cart paths where available.
- o Golf Carts must stay 30 feet away from the greens in any direction.
- o Golf Carts are operated at risk of operator. The Pass Holder will be responsible for the cost of repairing any damage to carts or the golf course resulting from improper operation.

☐ Driving Range:

o The Golf Pass includes range balls on the day of play.

☐ Dress Code:

o Golf Attire is preferred but not required. Tee shirts, jeans, cargo pants, and shorts are accepted. No tank tops, swimwear, or sweatpants.

Food & Beverage:

o All alcoholic beverages must be purchased from Florence Golf Links. No outside alcohol is permitted. Purchasing food on-site is preferred, but not required.

Pace of Play:

- \circ The first group of the day cannot tee off their second nine until <u>1 hour and 30 minutes</u> after their original tee time.
- The pace of play for 18 holes should be between 3.5 and 4 hours.

☐ Tee Times:

- Pass Holders must check-in at the Golf Shop before playing. Always...
- Tee times can be booked one week in advance.
- Only 3 tee times can be booked at any time.
- From May 1st through September 30th, the first tee time available for Pass Holders is 8 a.m. Pass Holders can move to an earlier tee time if one is available the day of play.

☐ Tee Time Cancellations & No-Show Policy:

- Pass Holders are responsible for managing the number of players in their times booked. Any
 changes must be communicated to the Golf Shop as soon as possible but no later than 24 hours
 before the scheduled tee time.
- O Pass Holders who no-show for a tee time will first receive a warning. After the first warning, Florence Golf Links reserves the right to charge the Pass Holder a \$100 No-Show Fee. Multiple no-shows may result in the suspension of golf privileges.

Violation of these Rules and Regulations may result in suspension of golf privileges.
